

**Regulations of participation**  
**in the 26th International Long-Term Care Conference**  
**on 17-19.09.2024 in Toruń**

1. These regulations (hereinafter referred to as the Regulations) define the rules of participation in the 26th International Long-Term Care Conference (hereinafter referred to as the Event), which will be held on 17-19 September 2024 in Toruń.
2. The Organizer of the Event (hereinafter referred to as the Organizer) is TZMO Foundation "Together We Change the World" with its registered office in Toruń, ul. Żółkiewskiego 20/26, 87-100 Toruń, registered in the District Court in Toruń, 7th Commercial Division of the National Court Register under KRS number 0000410895, NIP number 8792667214.
3. The event partner (hereinafter referred to as the Co-organizer) is Toruńskie Zakłady Materiałów Opatunkowych Spółka Akcyjna with its registered office in Toruń, ul. . Żółkiewskiego 20/26, 87-100 Toruń, registered in the District Court in Toruń, 7th Commercial Division of the National Court Register under the number KRS 000011286, NIP 8790166790, BDO 000013635, share capital PLN 2 640 000, including paid-up capital PLN 2 640 000.
4. An Event Participant (hereinafter referred to as the Participant) may be any natural person having full legal capacity.
5. To participate in the Event:
  - a) The Participant should, no later than on 23.08.2024, be registered via Platform [www.mkod.pl](http://www.mkod.pl) handling the Participant registration process available at the [www.mkod.pl](http://www.mkod.pl) (hereinafter referred to as Platform);
  - b) Participant's participation in the Event should be paid for by payment within 7 days of registration, no later than 30.08.2024, of the fee specified in point 7, unless the Participant has been released from this fee by the Organizer.
6. Registration of the Participant's participation in the Event (in accordance with point 5 (a)) and payment of the fee for participation in the Event (in accordance with point 5 (b)) may be made by the Participant himself or a third party. Registration of the Participant's participation in the Event (in accordance with point 5 (a)) and payment of the fee for participation in the Event (in accordance with point 5 (b)) by a third party is tantamount to ensuring that person is entitled to perform the above-mentioned activities on behalf of Participant.
7. The fee for participation in the Event is:
  - a) PLN 780 - for employees of long-term care institutions, after using the code received from the Organizer or Co-organizer,
  - b) PLN 1300 - for other Participants.The above amounts include. VAT
8. The fee for participation in the Event should be paid to the Organizer's bank account at Santander Bank Polska SA, number: 62 1090 1506 0000 0001 1858 1174
9. The date of payment will be the date of crediting the Organizer's bank account.
10. In particularly justified cases, the Organizer may, by way of an individual decision, exempt the Participant from the payment for participation in the Event.
11. The Organizer will send a VAT invoice for the fee for participation in the Event (by e-mail to the address provided during registration via the Platform) within 14 days after the Participant is registered and the fee is credited to the Organizer's bank account.
12. The fee for participation in the Event includes: participation in the Event as a listener on June 17, 18,19.09.2024, meals, breaks during the Event, participation in accompanying events and conference materials. The fee does not include the Participant's travel and accommodation costs;

- The Organizer does not reimburse the Participant for travel and accommodation costs or other costs incurred in connection with participation in the Event.
13. The number of participants for the Event is limited. The order of registration of the Participant's participation in the Event (in accordance with point 5 (a)) and the payment of the Participant's participation in the Event (in accordance with point 5 (b)) is decisive.
  14. The Participant may resign from participation in the Event; resignation is made by sending an email to [fundacja@tzmo-global.com](mailto:fundacja@tzmo-global.com) containing a declaration of will to resign from participation in the Conference. and the bank account number for reimbursement. In the event of resignation from participation in the Event made at least 7 days before the start of the Event or made within 3 days after the Organizer has informed about the change in the Regulations, program or date of the Event, the Organizer will refund the fee paid for participation in the Event of that Participant, minus the costs of making said refund. In other cases, the Organizer may refuse to return the paid fee for participation in the Participant's Event. The refund will be made to the bank account indicated to the Organizer in the above-mentioned e-mail messages.
  15. The participant will have full access to the Internet broadcast and recordings of the Event after logging in to his account, created during a separate registration on the website [mkod.pl](http://mkod.pl).
  16. The planned program of the Event has been published on the website [www.mkod.pl](http://www.mkod.pl). The Organizer may change the program or dates of the Event by informing about it on the website [www.mkod.pl](http://www.mkod.pl).
  17. By registering the Participant's participation in the Event (in accordance with point 5 a) and paying the Participant's participation fee in the Event (in accordance with point 5 b) an agreement is concluded between the Organizer and this Participant for participation in the Event on the terms specified in the Regulations, i.e. the Organizer undertakes to enable the Participant to participate in the Event, and the Participant may participate in the Event, under the conditions specified in the Regulations. The above contract is subject to Polish law.
  18. The Organizer and the Co-Organizer may photograph, film or record the course of the Event for the purposes of broadcasting in the mass media (television, radio, Internet, press) or for documentation or marketing purposes of the Organizer, Co-Organizer and other persons indicated by the Organizer or Co-Organizer. The Participant's participation in the Event is tantamount to the Participant's consent, without time and territorial limits, to the recording, reproduction, dissemination (in particular by posting on websites) and other use of the Participant's speech, voice and image in connection with the Event by the Organizer, Co-organizer and other persons indicated by the Organizer or Co-organizer.
  19. The Organizer processes the Participants' personal data provided to the Organizer and therefore informs:
    - a) Personal data are processed in accordance with applicable law, in particular Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to processing personal data and on the free movement of such data, and repealing Directive 95/46 / EC (General Data Protection Regulation) (hereinafter referred to as GDPR).
    - b) The administrator of personal data is the Organizer - TZMO "Together We Change the World", ul. Żółkiewskiego 20/26, 87-100 Toruń.
    - c) The legal basis for the processing of personal data is Art. 6 sec. 1 lit. a) GDPR, i.e. the data subject has consented to the processing of his personal data for a specific purpose.
    - d) Personal data is processed for the purpose of:
      - Participant's participation in the Event and for the purpose of handling such participation;
      - Providing the Participant by the Organizer with information on training courses, other activities related to the care of a dependent, including, inter alia, on publications and events, as well as marketing and commercial information within the meaning of the Act on the provision of electronic services (if the Participant has given additional consent).
    - e) The recipients of personal data are the Co-organizer and persons employed by the Co-organizer and other trusted entities cooperating with the Organizer - to the extent

- necessary to implement the above-mentioned the purposes of processing, in particular the Platform Operator; personal data may also be made available to public authorities and other entities authorized to do so under the provisions of law, upon their request.
- f) Personal data is not transferred to a third country or to international organizations.
  - g) Personal data is stored until the above-mentioned the purposes of the processing.
  - h) The Participant has the right to request the Organizer to access their personal data, and in the cases specified in the GDPR, also to rectify them, transfer their deletion or limit processing.
  - i) The participant has the right to withdraw consent at any time without affecting the lawfulness of the processing which was carried out on the basis of consent before its withdrawal; the consent may be withdrawn, for example, by sending a declaration of consent withdrawal to the e-mail address [fundacja@tzmo-global.com](mailto:fundacja@tzmo-global.com).
  - j) The participant has the right to lodge a complaint to the President of the Personal Data Protection Office if he or she believes that the processing of his personal data violates the provisions of the GDPR.
  - k) Providing personal data is not a statutory or contractual requirement and is voluntary; failure to provide data, however, prevents the implementation of the above-mentioned for the purposes of processing, i.e.
    - prevents the Participant from participating in the Event;
    - prevents the Organizer's marketing activities towards the Participant.
  - l) In connection with the processing of personal data, there is no automated decision making, including profiling.
  - m) In matters relating to the processing of personal data and the exercise of rights related to the processing of personal data, you can contact the data protection officer, who is Mr. Jan Stemposz; address: Toruńskie Zakłady Materiałów Opatrunkowych SA, ul. 20. The Participant is obliged to participate in the Event in a manner consistent with Polish law and good manners, including compliance with order regulations and safety rules in force at the place of the Event and the Organizer's order. The Participant is also obliged to:
    - a) use the Platform in a manner consistent with the law, morality, as well as the provisions of the Regulations, with respect for personal rights, intellectual property rights and other rights of third parties,
    - b) have appropriate rights to the content posted on the Platform or using the Platform or provided to the Organizer,
    - c) enter only factually correct data on the Platform and inform the Organizer of any changes to these data,
    - d) do not use devices, software and methods that may disrupt the operation of the Platform,
    - e) not introduce content that is illegal or inconsistent with the Platform.
  21. The Organizer is not responsible for damages caused by Participants and damages that may be suffered by Participants before, during and after the Event.
  22. The Organizer does not provide Participants with third party liability insurance.
  23. The Organizer does not provide Participants with accident insurance and insurance of treatment costs, in particular in connection with a sudden illness, accident or a consequence of a chronic disease.
  24. The Organizer recommends Participants to conclude individual insurance policies covering the risks indicated in points 22 and 23.
  25. The organizer recommends Participants from the European Union and the European Free Trade Association to have a valid European Health Insurance Card, which allows them to obtain the necessary basic medical care free of charge in health care units in Poland. In order to obtain the Card, the Participant should contact the health administration unit of the country of residence and follow the local procedure.
  26. The Regulations are governed by Polish law.
  27. The Organizer and the Platform Operator will not be liable to the Participants for the

consequences of force majeure, i.e. extraordinary external events not attributable to the Organizer or the Platform Operator, preventing the Participant's participation in the Event or the use of the Platform, which could not be predicted or prevented by ordinary means, even with due diligence, including in particular such as war, terrorist attack, hacker attack, riots, natural disaster.

28. For important reasons, beyond the control of the Organizer, the Organizer may change the Regulations by informing about it on the website [www.mkod.pl](http://www.mkod.pl).
